Showcasing key projects to stakeholders from states and the centre is important for them to take note of and learn from and vote for their preference through our national exhibition that will be organised.

Amongst the union ministers that have honoured us by personally receiving SKOCH Award include Mr. Nitin Gadkari, Mr. Narendra Singh Tomar, Mr. Suresh Prabhu, Ms. Maneka Gandhi and Mr. Ramesh Pokhriyal 'Nishank'. Several Chief Ministers as well as Secretaries to the union government too have received the SKOCH Award.

I would urge your Ministry to participate and contribute to the country's body of knowledge. In addition to the Governance Assessment, our evaluation of your efforts and response in controlling COVID19 is also underway. **The last date is 14 November 2020** to enable us to evaluate and release the report in time.
