**OFFICE ORDER**

Consequent upon the recommendation of the Departmental Screening Committee for grant of financial up-gradation under the "Modified Assured Career Progression Scheme," in terms of DOPT O.M. No.35034/3/2008-Estt.(D), dated 19.5.2009 and clarifications there to issued by Govt. from time to time, the following Assistant Research Officers (Scientific Cadre) are granted financial up-gradation under MACP Scheme w.e.f the dates as mentioned against their names:-

2. The above up-gradation is further subject to the following conditions and in terms of DOPT. O.M. No.35034/3/2008-Estt.(D), dated 19.5.2009 and clarifications there to issued by Govt. from time to time.:-

i) His pay in the higher grade shall be fixed under the provision of FR 22(1)(a)(1). To get his pay fixed in the higher pay he may exercise his option either from the date of his promotion/ up-gradation or from the date of his next increment viz., 1<sup>st</sup> January or 1<sup>st</sup> July of the year (as applicable). The pay and the date of increment would be fixed in accordance with clarification No.2 of Department of Expenditure's O.M. No.1/1/2008-IC, dated 13.9.2008 and there shall be no further fixation of pay, at the time of regular promotion if it is in the same grade pay as granted under MACP Scheme.

ii) He is also entitled to exercise option for choosing date of fixation within one month from the date of issue of this order, as per rules.

- iii) There shall not be any change of designation on the up-gradation and the incumbent shall retain his old designation.
- iv) The financial up-gradation shall not confer any privileges related to higher status and he shall continue to be governed by status of the post, which he is now holding.
- v) The above up-gradation shall not have any relevance to the seniority position, which shall remain as in the post, which he is now holding.
- vi) The individual while accepting the above up-gradation shall be deemed to have his unqualified acceptance for regular promotion on occurrence of vacancy subsequently. In case, he refuses to accept the higher post on regular promotion subsequently, he shall be subject to normal debarment for regular promotion as prescribed in the general instructions in this regard.
- vii) The financial up-gradation is subject to audit verification and recovery, if any, at any stage.
