**TERMS AND CONDITIONS:**

1. The sealed envelope containing the quotation should be superscribed as "**Quotation for supply of Data Forms & Registers due on 09-03-2011**" and addressed to the Executive Engineer, Meghna Investigation Division CWC, Yingyar Villa, Motinagar, Shillong – 793014.
2. The sealed quotations should be submitted to this office by **1500 hrs. on 09-03-2011**. The quotations received shall be opened at 1530 hrs. on **09-03-2011** in the presence of bidders or their authorized representatives.
3. The rates are to be quoted F.O.R. destination inclusive of packing forwarding, freight, insurance, if any, at office of the Executive Engineer, Meghna Investigation Division, CWC, Yingyar Villa, Lumpynggad, Shillong.
4. The rate should be indicated in both figures and words. The quotationers shall initial corrections/ overwriting if any in the quotation.

5. The sample of Forms/Registers may be collected/seen at the O/o the undersigned on all working days up to 08-03-2011 during office hours from 10 am to 5 pm.
6. The quantities mentioned above are tentative only and may vary the time of placing the supply order subject to requirement.
7. All duties, taxes (except octroi) transportation and other levies payable by the supplier/contractor under the contract shall be included in the total price. Actual CST/VAT may be indicated separately. Octroi exemption certificate, if necessary, shall be issued on request. Any damage or loss occurred during this process should be borne by the agency itself.
8. The payment will be made only after satisfactory supply of materials as per sample in good condition and on submission of pre-receipted bills in triplicate, through Account payee cheque on State Bank of India, Shillong or DD for outstations.
9. The quotation shall remain valid for a period of not less than 90 days from the date of opening.
10. The purchaser will evaluate and compare the quotations determined to be substantially responsive i.e. which are properly signed and conform to the terms and conditions and specifications.
11. The purchaser will award the contract to the bidder whose quotation has been determined to be substantially responsive and who has offered lowest price.
12. Notwithstanding the above, the undersigned reserves the right to accept or reject any or all quotations and cancel the process at any time prior to the award of the contract without assigning any reason thereof.
