3.	Similar works* successfully completed during last five years : i) Three similar works of Rs 2.00 Lakh, or ii) Two similar works of Rs 3.00 Lakh, or iii) One similar works of Rs 4.00 Lakh each.
4.	Performance Report: A performance report from the Government Department / Public under taking duly signed by the competent authority, of having successfully completed similar work mentioned at S.No. 3 above and / or satisfactory performances in works being handled.
5.	Undertaking of not being blacklisted: An undertaking in the specified Performa that the contractor has not been blacklisted anywhere in past.
