## **TERMS & CONDITION FOR CONTRACT :-**

1. The guard of age 18 to 60 years should be provided and no guard should be provided below the age of 18 years & above the age of 60 years.
2. The guard should be provided round the clock & their duty should not be more or less than 8 hrs.
3. The guard should be provided for round the month on the weekly off & leave on national holiday for which they should be paid wages on monthly basis and other guard should be provided on weekly off, leave on national holiday on daily basis for which they should be paid on daily rate.
4. Work should be done satisfactory.
5. It will be the responsibility of the agency to maintain discipline, duty register, norms of duty, uniform and performance of guard their timely payment, their safety, incident of theft and their accident.
6. Guard should perform duty with uniform & identity card which will be provided by the agency.
7. Payment will be made through A/C Pay Cheque / DD on submission of bill in triplicate after satisfactory completion of work in each month.
8. The undersigned has reserved right to reject or accept any or all tendered along with discontinuation of order without assigning any reason thereof.
9. The work order will be effective when the telemetry instruments will be installed at respective site.
10. The labour rate will be automatically enhanced when ever it will be enhanced by the Chief Labour Commissioner ( C ), M/O Labour & Employments, New Delhi on the basis of increase of consumer price Index.
11. Income tax & education cess will be deducted as per rule.
