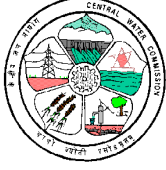

TERMS AND CONDITIONS:

(1)The sealed envelope containing the quotation should be super-scribed as "Quotation for supply of tyre & tubes" and addressed to the Executive Engineer, Mahanadi Division, Central Water Commission, Doctor's Colony, Burla-Sambalpur – 7

(The rate should be indicated in both figures and words. Corrections/ overwriting if any in the quotation shall be made by initialling, dating and re-writing.

(2)The rate quoted shall be firm and final. The price shall be inclusive of transportation. Any damage occurred during transit should be borne by the agency itself.

(3)Authorised dealership certificates and VAT Clearance certificates may be enclosed along with quotations.

(4)(TIN/PAN number of the firm must be mentioned on the quotation of the firm.

(5)Make and Model number of the proposed tyres & tubes must be mentioned while quoting the rates. Quotation will be liable for rejection if the rates are quoted without mentioning make and model number of the proposed battery.

(6)The purchaser will evaluate and compare the quotations determined to be substantially responsive i.e. which are properly signed; and conform to the terms and conditions and specifications.

(7)Guarantee/Warranty is one year from the date of successful testing.

(8)The delivery shall have to be made within 15 days from the date of issue of supply order.

(9)Normally, the lowest rates quoted will be accepted but the undersigned reserves the right to reject any or all the quotations without assigning any reasons.

(10)Any dispute arising in this supply will be referred to Superintending Engineer, Hydrological Observation Circle, Central Water Commission, Bhubaneswar and his decision will be final and binding on both the parties.

(11.)The full and final payment will be made within 20 days after full supply or pre-receipted bills in triplicate, whichever is latter, through Demand Draft (after deducting DD Commission) payable at near by SBI branch for outstation agencies/ crossed cheque payable at SBI , Burla branch for local agencies.
