In pursuance of the Sanction of the Secretary, Department of WR, RD&GR, Ministry of Jal Shakticonveyed through Training Directorate, CWC's Office Order No. 3/2A/2019-Trg./5215-5224 dated 16.07.2019 for Sponsoring of Sh. Kaushlendra Singh for 2 Years M.Tech Course in WRD Programme at IIT Roorkee and Letter of Provisional Admission to the Course from IIT Roorkee vide letter No. WR/Admn/2019-20/576 dated 18.07.2019 for the academic session beginning in 2019-20 after submitting the required Bond of Rs18.50 Lakhs to CWC Administration communicated vide CWC office Letter No.5/20/2017/Estt.V/1297-1299 dated 24/07/2019, Sh. Kaushlendra Singh, SDE, CSSD is hereby relieved from his duties to persue 02 years M.Tech programme at WRD,Roorkee from dated 25.07.2019 (AN) with following terms and conditions:

- In terms of rule 50& 51 of the Central Civil Services (Leave) Rules 1972. Sh. Kaushalendra Singh a Central Water Engineering (Group 'B' Service is granted Study Leave for 24 Months from 26.7.2019 to 25.7.2021 for pursuing Two year M.Tech Course in WRD Programme at IIT Roorkee
- 2. On completion of the study Sh. Kaushalendra singh SDE CWC will submit to the Central Water Commission the certificate of completion of course of study undertaken indicting the date of commencement and termination of the study with remark, if any of the authority in charge of the course of study Sh. Kaushalendra Singh shall submit to the Government of India on his return, a complete report on the course of study undertaken by him during his Earned Leave in combination with Study Leave.
- 3. If Sh. Kaushalendra Singh resign from Government Service or otherwise quit service without returning to duty after the period of Study Leave or within a period of Two years after such return to duty or fails to complete the course of study for which the study Leave has been sanctioned and is thus, unable to furnish the certificate as required under sub-rule (5) of rule 53. He shall be required to refund, as provided under Rule63(1) of CCS (Leave) Rule, 1972.
 - (i) The actual amount of leave salary, study allowance, travelling and expenses, if any incurred by the Government of India; and
 - (ii) The actual amount, if any, of the cost incurred by other agencies such as foreign Government, Foundations and Trusts in connection with course of study, together with interest hereon at the rates applicable for the time being in force on Government loans, from the date of demand before his resignation is accepted or permission to retire is granted or has quitting service otherwise.
- 4. Sh. Kaushalendra Singh is entitled to draw leave salary during the period of study leave in accordance with Rule 56(1) of the CCS(Leave)Rule,1972.

- 5. He has executed Bond Form-7 for Rs1850000/-(Rupees Eighteen lakhs Fifty thousand) and as prescribed vide DoPT O.M No.13026/4/2012-Estt(L) dated 18.2.2014 and same has been accepted by the Competent Authority in Central Water Commission.
- 6. The Study Leave will not be debited against the leave account of shri Kaushalendra Singh AD-II/SDE, CWC, New Delhi.
- 7. Shri Kaushlendra Singh,SDE CWC is also governed by the terms & condition as enumerated in Training Directorates Office Order No. 3/2A/2019-Trg/5215-5224 dated16th july,2019
