- G.S.R. 133.—In exercise of the powers conferred by the proviso to article 309 of the Constitution, the President hereby makes the following rules to amend the Ministry of Water Resources, Central Water Commission, Staff Car Driver (Special Grade), Group 'B' Post, Recruitment Rules, 2011, namely:-
- 1. (1) These rules may be called the Ministry of Water Resources, River Development and Ganga Rejuvenation, Central Water Commission, Staff Car Driver (Special Grade), Group 'B' Post, Recruitment Amendment Rules, 2018.
 - (2) They shall come into force on the date of their publication in the Official Gazette.
- 2. In the Ministry of Water Resources, Central Water Commission, Staff Car Driver (Special Grade), Group 'B' Post, Recruitment Rules, 2011,-
 - I. For rule 2, the following rule shall be substituted, namely:-
- "2. Number of post, classification and level in pay matrix.—The number of the said post, its classification and the level in the pay matrix attached thereto, shall be as specified in columns (2) to (4) of the Schedule annexed to these rules.";
 - II. in the Schedule,-
 - (a) in column (4), for the column heading and the entries relating thereto, the following column heading and entries shall be substituted, namely:-

- (c) in column (11), Note 2 shall be omitted.
