# Minutes of the Meeting held on 24.10.2019 to Review Status of Pending Pension cases under CWC.

In continuation of the review meeting held on 23.09.2019, a meeting under the Chairmanship of Member (RM), CWC was held on 24.10.2019 in his Chamber at O/o Member (RM), Central Water Commission, 2<sup>nd</sup> Floor (South), Sewa Bhawan, New Delhi to review the status of Pending Pension cases discussed in 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> Video Conference in respect of UGBO, BBBO, MERO, NBO & YBO, CWC.

The list of participants is at **Annexure**.

At the outset, Member (RM) welcomed all the participants. He expressed his deep concern on the Pending Pension Cases with PAO, CWC. His main emphasis was related to resolving the pending pension cases in time bound manner and not to keep any cases pending at PAO level. Based on the deliberations held during the meeting the following decisions emerged:

## **Status of Pension Monitoring System**

1) Secretary, CWC appraised summary of pending pension cases discussed in 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> Video Conference in respect of UGBO, BBBO, MERO, NBO & YBO, CWC and status of pension cases received from concerned DDOs on 23.10.2019 in line with the instructions given by Member (RM). The following brief status of pending pension cases as on 24.10.2019 was presented:

2) Member (RM) observed that PPO No. were issued in respect of only 11 cases since the last review meeting held on 23.09.2019 with 76 cases still pending at PAO level. This was viewed very seriously and PAO, CWC was advised to proactively pursue the cases in coordination with respective DDOs. He reiterated the importance of adherence to the time schedules for disposal of the cases so that the end beneficiary are not deprived of their legitimate right of getting pension and other terminal benefits within the stipulated time frame.

### (Action: All Concerned DDOs/PAO, CWC)

- 3) PAO, CWC informed that out of 39 pending pension cases in respect of UGBO shortlisted for scrutiny in the last review meeting, PPO No. has been issued for 8 cases, 25 cases have been returned to Establishment IV/Concerned DDOs for compliance and 6 cases are under process. Member (RM) observed that even after repeated emphasis on **not returning the pension cases**, a major portion of cases is still being returned by PAO, CWC and the cases are not getting settled. He emphatically observed that concerned DDOs and PAO, CWC may sit together, sort out the issues and settle the cases in a time bound manner.
- 4) As per discussions held, it was decided that case wise calendar mentioning the timeline for resolution of remaining pending pension cases (118 Numbers in total) will be prepared by PAO, CWC and the same will be submitted to Secretary, CWC by 25.10.2019 positively. Along with this, the case-wise details of requisite information /compliance sought / clarifications sought in respect of all these 118 cases by PAO also needs to be provided. Based on the PAO calendar, an order will be issued for concerned DDOs to personally visit PAO, CWC along with their dealing hands with full preparation to resolve the cases within that time frame. DDOs will ensure that they collect all requisite documents /compliance sought/ clarifications sought by PAO, CWC before visiting CWC HQ.

#### (Action: PAO, CWC / DDOs, CWC / e-Gov Cell, CWC)

5) It was decided that next review meeting in this regard will be held on 25.11.2019. PAO, CWC & concerned DDOs will submit the updated status of pending pension cases by 22.11.2019.
