#### **CIRCULAR**

Sub: Resolution of Pending Pension Cases in CWC as per PAO Timeline.

Ref: Minutes of Meeting issued vide letter no J-11015/1/2019-e-GOV CELL/I/9790/2019 dated 29.10.2019

Kind reference is invited to the status of pending pension cases at various offices of CWC and PAO, CWC which has been taken on serious note by the Senior Officers of Central Water Commission and three successive Video Conference (V.C.) Meetings have been chaired by Member (RM) CWC with all the respective Executive Engineers of Regional Offices and Pay & Accounts Office (PAO) CWC on 17.07.2019, 01.08.2019 and 21.08.2019. Further two review meetings have also been held under the Chairmanship of Member (RM) CWC on 23.09.2019 and 24.10.2019. The status of 171 nos. pending Pension cases in respect of Upper Ganga Basin Organisation (UGBO), Brahmaputra & Barak Basin Organisation (B&BBO), Mahanadi & Eastern Rivers Organisation (MERO), Narmada Basin Organisation (NBO) and Yamuna Basin Organisation (YBO) have been reviewed in these meetings in the presence of Officers from PAO, CWC and field officers of CWC.

It has been observed that even after repeated and intense interventions by Senior Management of CWC, only 53 Nos of PPO have been issued till date. In this regard, it has been decided that the remaining 118 cases will be taken up by PAO, CWC on priority. Accordingly, it has been decided that 25 pension cases returned by PAO, CWC (as per List Attached at Annexure) corresponding to MGD-I, MGD-II, MGD-III, HGD, Narmada Division will be taken up during 11<sup>th</sup> to 15<sup>th</sup> November, 2019. The exact date of visit between 11<sup>th</sup> to 15<sup>th</sup> November, 2019 may be mutually decided by concerned Executive Engineer and PAO, CWC based on their convenience/availability under intimation to this office.

The concerned Executive Engineers are hereby informed to personally visit PAO, CWC along with their dealing hands with full preparation to resolve the cases within the time frame mentioned. Respective Executive Engineers will have to ensure that they carry all requisites / compliance / clarifications sought by PAO, CWC before visiting CWC HQ to streamline the pension resolution. PAO will ensure that all the requisites sought have been obtained so as to ensure that the Executive Engineers do not have to visit them again for the same purpose. The venue of the meeting will be the Training Lab, S M Dte., 6<sup>th</sup> Floor (South), Sewa Bhawan, New Delhi. A case wise feedback will be submitted by the Executive Engineers to e-Governance Cell after their visit for appraising Member (RM), CWC.
