Subject: - One day consultation workshop with States on Concept Note on National Water Conservation Scheme formulated by DoWR, RD & GR.

Sir/Madam,

I am directed to say that DoWR, RD & GR is organizing a one-day consultation workshop on the concept note (prepared by DoWR, RD & GR) on National Water Conservation Scheme under the chairmanship of Secretary on 15.11.2019 at 10.00 AM in the conference hall of Shram Shakti Bhavan, New Delhi.

2. In this regard it is to submit that Government of India has launched the Jal Shakti Abhiyan (JSA) to improve water availability including ground water conditions in the water stressed blocks of 256 districts in India. In this regard, team of officers from Central Government along-with technical officers from Ministry of Jal Shakti have visited water stressed districts and worked in close collaboration with district level officials to undertake suitable demand side and supply side interventions. Most of the works under the JSA were planned/executed through MGNREGS funds. During various interactions, many Nodal officers/Technical officers have suggested for formulating a dedicated water conservation scheme for successful implementation of JSA interventions due to absence of enabling provisions in the provisions of the MGNREGS scheme/other existing schemes.

3. In view of this, DoWR, RD & GR has prepared a concept note for National Water Conservation Scheme with the aim of implementing suitable interventions for effective water conservation and rainwater harvesting in the country with special emphasis in the water stressed areas. Certain interventions have been identified to be undertaken under the scheme to improve the ground water situations in the country. The scheme has been proposed to be implemented in mission mode with active participation of all States/UTs and other stakeholders. The scheme has been planned as a Centrally Sponsored scheme with funds sharing pattern/other provisions as per the attached Concept Note.

4. States are hereby requested to kindly forward their valuable suggestions/proposals/modification etc for further improvements of the proposed scheme. A format as per appx has been devised for seeking inputs from the State Governments in this regard. It is hereby requested to kindly nominate suitable officer(s) to make it convenient to attend the above mentioned workshop with valuable suggestions/advice along-with the attached format.
