- 3. The promotion of the above 24 officers will be effected from the date they assume charge of the higher post at the place mentioned against their names and are directed to join at their respective place on promotion within 30 days from the date of issue of this order. No request or representation for modification in place of posting or to forgo the promotion shall be entertained after 30 days of the issue of this order.
- 4. The relieving of above officers will be subject to giving over a detailed "Handing Over Note". Further, LPC to the above officers shall be issued by the concerned officer/DDO only after the handing over notes in detail are given by them as per instruction of CWC issued vide O.M. No. 9/2/2009-WPC/1581 dated 1.04.2011.

- 5. As per rule 20 of CCS (Conduct) Rules, no Government servant shall bring or attempt to bring any political or other outside influence to bear upon any superior authority to further his interest in respect of matters pertaining to his service under Government. If anyone through himself/herself or through their relatives/friends brings political pressure for change of place of posting, disciplinary action will be initiated against him/her without any further notice/communication.
- 6. Junior Engineers who forego their promotion to the grade of AD Gr.II/SDE in the current vacancy year 2019 will not be considered for promotion in the next vacancy year 2020.
- 7. After issue of posting order to the respective field offices, the further posting of the officers will be decided by the respective Chief Engineer's office.
- 8. Service Books of all the officials may be forwarded to the new place of posting after making all entries (Service verification entries including 18/25 years, CGEGIS, all leave record including leave salary and pension contribution in respect of deputationist, order of relieving from the present place of posting etc.). Incomplete service Books received will be returned.
