content at suitable time mutually agreeable between the agency developing the site and CWC so that the Hindi content also can be loaded before the statutory audit process.

Therefore, the following action plan has been formulated:

a) All the field Chief Engineers shall provide the translated content of their respective micro-sites in Hindi to SM Directorate by 6th March 2020.

[Action: Chief Engineers of Regional Offices of CWC]

b) The present English content is comparatively less in case of micro-sites of CWC(HQ). Therefore, SM Directorate in collaboration with O/o Chief Engineers of CWC(HQ) will translate the existing content of micro-sites of CWC(HQ) from English to Hindi to expedite the process of obtaining the GIGW compliance.

[Action: S M Dte. / Chief Engineers at CWC(HQ)]

c) Subsequent translation of additional /modified content in respect of the micro-sites of CWC(HQ) and regional offices from English to Hindi shall be done by respective Chief Engineers of micro-sites.

[Action: Chief Engineers (HQ/Regional Offices of CWC)]

3) In view of 75th Year Celebration of CWC, it is decided that SM Dte may communicate with all the Chief Engineers (HQ & Field) requesting them to provide the translated content of their respective microsite in Hindi in time bound manner preferably on or before 6th March 2020.

[Action: S M Dte, CWC]

4) It is observed that the name and designation of the officers in microssites are not up-to-date in some cases. In this regard, SM Dte. is requested to communicate with all the Chief Engineers to keep name/designation, circulars, RTI etc. pertaining to their micro-sites up-to-date.

[Action: S M Dte, CWC]

5) To identify nodal officer for each and every section of CWC main website (excluding microsite) so that content updation may be done in smooth manner. In this regard, role matrix with the approval of Chief Engineer (HRM) is to be prepared and published at CWC website.

[Action: SM Dte, CWC]
