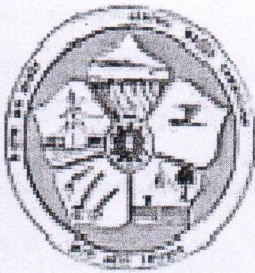
OFFICE ORDER
