

Office Order

*Subject:-Exercise of powers in respect of contingent expenditure under Schedule-V and miscellaneous expenditure under Schedule-VI of Delegation of Financial Power Rules (DFPRs) 1978.*

Consequent upon delegation of powers to Chairman, CWC as HoD vide MoWR, RD&GR Order No.A-36013/2/2017-Admn. dated 23.01.2019 and in exercise of powers vested in Chairman, CWC as HoD under Rule 13 (3) of Delegation of Financial Powers Rules 1978; in supersession of all earlier orders authorizing subordinate authorities to exercise powers in respect of contingent expenditure under Schedule -V and miscellaneous expenditure under Schedule - VI of DFPR 1978, Chairman, CWC authorizes the powers in respect of expenditure covered under the above schedules as per Annex-I&II attached.

2. Exercise of powers are subject to the financial limits and procedures being in accordance with the provisions of General Financial Rules and Delegation of Financial Powers Rules, economy instructions issued by Finance Ministry, general and special orders issued by Government and CWC from time to time, fiscal Codes and Procedures and the limits being within the budgetary allocation for the year.
