The further details of the aforesaid posts along with eligibility criteria required for the same are given in the Vacancy Circular available on the website of Ministry of Jal Shakti. The appointment of all the posts except the post of 'Registrar' will be on deputation/re-employment/direct recruitment basis. In the case of appointment to the post of 'Registrar' no direct recruitment is admissible. The maximum age of the applicant should not be more than 56 years for recruitment on deputation basis and 45 years for candidates for direct recruitment as on the date of Advertisement. In the case of direct recruitment a person who is selected for the post will hold the said post on co-terminus basis with the life of the Tribunal and he will not have any claim for regular absorption in Government.
