- 2. In a meeting of the Monitoring Committee on Restructuring of the Brahmaputra Board, held in this Department on 31.01.2020, the Chairman, Brahmaputra Board has raised an issue regarding attendance of these CWES Officers in meetings being convened by him. It has been reported that, these CWES Officers, sometimes are not able to attend the meetings convened by the Brahmaputra Board, citing their own regular work or meeting by their Controlling Officers of the CWC.
- 3. The matter has been discussed in the Monitoring Committee and it has been decided that, if the meeting of the Brahmaputra Board is convened under the Chairmanship of the Chairman, Brahmaputra Board, such meetings should have the precedence of any other meetings being convened by the Controlling Officers of the CWC and these CWES Officers, who are holding additional charges of various posts of Brahmaputra Board, shall attend the meeting convened by the Chairman, Brahmaputra Board.
- 4. In the light of the above, you are requested to issue necessary instructions to your offices in the North-Eastern Region, under intimation to this Department.
