Global Webinar on the Impact and Recovery from COVID-19 in the Irrigation and Drainage Sector

Monday, May 18, 2020

The World Bank, the International Commission on Irrigation & Drainage (ICID), and the 2030 Water Resources Group (WRG) intend to organize a webinar on May 18th, 2020 to discuss the impact of COVID-19 on the irrigation and drainage (I&D) sector and how the sector can contribute to future economic recovery. The primary objective of this webinar is to share experience in addressing the multiple challenges related to COVID-19 and the needs of irrigation practitioners, thereby improving the understanding of COVID-19 impacts and of the role that irrigation can play in recovery.

The webinar will bring together irrigation practitioners (government officials, service providers, private sector, farmers) from around the world to share lessons and learn from each other's experience. It will focus on the measures that countries are already implementing in response to COVID-19, and on the kinds of support needed to ensure that the I&D sector can continue providing the best possible service given the current and future circumstances.

Rationale

While the situation varies depending on the region, the sector is currently facing disruptions in the provision of irrigation and drainage services as well as deferral of infrastructural maintenance due to COVID-19 response restrictions and fiscal stress. Irrigation services may also suffer from labor absenteeism and disruption in the supply chain for provision of inputs and equipment, as inputs for farming may not be available or not arrive on time due to COVID-related disruptions. This can mean that farmers may miss an entire season of food production. Works may also be delayed or stopped altogether jeopardizing future agricultural production. Lastly, liquidity concerns may be experienced through a reduction in budgets for irrigation agencies as funds are redirected to health and other economic sectors.

Our sector is now seeking solutions that enable the maintenance of service and/or accelerating the implementation of irrigation works in the face of the pandemic. The primary early actions revolved around cushioning the effects of liquidity constraints for the sector, the safety of laborers on work sites and service delivery staff and adjusting and scaling programs for increasing employment opportunities. Going forward, the emphasis will be on reopening of the economy and the role of irrigation in such efforts. This includes continued service delivery, addressing financing constraints, and the safe implementation of capital and O&M works. The core focus of future actions will likely be on (1) ensuring critical irrigation and drainage services to sustain millions of livelihoods and (2) supporting resilient economic recovery for farms and firms with a view of longer-term sustainability.

Labor-intensive civil works programs have become part of a global response to the impact of COVID-19 on employment and incomes. Irrigation and drainage works have been presented as engines for employment and productivity that can lead to job creation, both skilled and unskilled, direct or indirect. They can be traditional labor-intensive approaches, small enterprise intensive construction, inputs-for-assets programs, community contracting, etc.









Moreover, the I&D sector is already in the process of repositioning itself towards modern and sustainable service provision and COVID-19 adds to existing sector transformation needs. To that end, embedding traditional irrigation sector support into broader strategies for a more resilient rebound from this crisis includes transforming governance and service provision, supporting watershed management, and an overall greening the sector. Besides providing irrigation, farm roads, water supply and catchment conservation, large civil works programs can support sustainable natural resource management (e.g. riverbank protection, large-scale landscapes and forestry management, etc.).

Some key questions to be answered through the discussion:

- How do we support service providers to ensure continuity of critical service delivery and the vulnerable in accessing irrigation services?
- How do we safeguard proper management of ongoing I&D works and maintenance of existing ones?
- How do we envision the economic reopening post-COVID and what are steps to take?
- Which new ways of work have we discovered that will improve service provision post-COVID?
