As you are aware, the Department of Legal Affairs (DoLA) has for effective monitoring and quick disposal of cases involving Union Government has in association with NIC remodeled Legal Information Management and Briefing System (LIMBS) Ver.2.0 on a robust and secure platform in place of existing version.

- 2. The new initiative of LIMBS 2.0 so envisaged is to facilitate various Ministries and Departments to login using their credentials and track status/information of their cases such as pending cases, contempt cases compliance/appeal, subject-wise/counsel wise, filed and pending cases, pending orders, upcoming cases etc. It will also allow a view of comprehensive dashboard which will display case related data of all the on-board Ministries/Departments. A set of customized reports can be generated at various stages of Govt. cases such as Advice, Drafting, Filing, Pendency, Disposal, Adjournment, Appeal etc., by Ministry level Nodal Officers and the same can be monitored effectively. Using predictive analysis, software is proposed to monitor disposal time for cases, lawyer performance indicators etc.
- 3. In order to achieve the envisaged objectives of the LIMBS Ver.2.0 as above, it would be henceforth essential to enter the CNR No. of each case in the LIMBS database for its integration with e-Courts Cloud based application for fetching case proceedings directly from API.
