Minutes of the Meeting held on 17.12.2020 to Plan Future Activities of CWES Officers' (Gr. A) Welfare Committee.

A meeting of CWES Officers' (Gr. A) Welfare Committee members was held on 16.12.2020 to discuss the future activities of the Committee.

Based on the deliberations held during the meeting the following decisions emerged:

- 1. The Farewell function of Sh. R.K. Jain, Chairman, CWC and Sh. M. Sai Sudarshanam, Director, CWC is to be held on 31.12.2020.
 - a. As per discussion held with senior officers, the Farewell committee is of the view that the function may be held in Auditorium, Library Building, CWC with limited attendance. The hall adjacent to the auditorium may also be opened for accommodating more number of officers. It will also be held in virtual mode from Training Hall, Sewa Bhawan.
 - b. Further, the proceedings may be webcast to enable distance viewers to participate online. Refreshment packets may be collected by Welfare Committee members from Library Building as well as Training Hall, Sewa Bhawan.
 - c. A short presentation on contributions/achievements of Chairman, CWC (preferably in the form of a video with Slideshow of Pictures with background Voice) can be prepared and displayed during the event.
 - d. Necessary help in this regard may be taken from SMD and PCP Dte., CWC.
- 2. As per the opinion of senior officers, it has been decided that a function for New Year Celebration may be held in January, 2021.
- 3. Discussions were earlier held with Director (Training), CWC And Director (PCP), CWC (under direction from Chief Engineer (HRM), CWC) regarding allotment of space in Library Building for activities related to Welfare Committee. It has been decided to convene a meeting with all concerned to expedite the same. After getting some space allocation, the committee can decide for equipping activity centre with some sports related facilities like Table Tennis Table, Carrom Boards, Chess Boards, etc. And some musical instruments like Guitar, Tabla, Harmonium, etc. to strengthen our sports and cultural team.

Efforts are required to increase the membership. At first instance, efforts can be made personally contact Director Level Officers at CWC HQ and get the membership form filled.
