However, the consignment has not been delivered as per terms and conditions of the GeM bid even after grant of extension of sufficient time.

A Supplier Discipline Committee has examined the matter and it has been decided that as per the provisions provided in Clause 2.4.2 and clause 2.4.5 of Chapter-2 ("Consultants, Service Providers and Governance Issues") of *Manual for Procurement Of Consultancy & Other Services 2017* issued by Department of Expenditure, Ministry of Finance. of the said Manual, both the vendor i.e. M/s Niyura Technologies Pvt. Ltd. and OEM i.e. M/s Lenovo India Pvt. Ltd., are debarred for a period of 3 months as an interim provision pending final decision of the Committee. The proceedings for encashing/ invoking of Bank Guarantee submitted by vendor has been initiated.

The Committee will take the final decision after following due procedure.
