The proposal regarding Consideration of 50% of the period of service rendered as Seasonal Khalsis (without temporary status) and 100% of the service rendered as Seasonal Khalasis with temporary status for pension benefits, was taken up with DoWR, RD&GR.

- 2. DoWR, RD&GR vide its letter No. A-50011/32/2020-E-I, dated 1st January, 2021 conveyed that "Counting of service for pension benefits and subsequent pension benefits being provided to Seasonal Khalasis under WCE of CWC is being done in terms of Scheme issued by the Department with the approval of the Cabinet, who fulfill the eligibility criteria in terms of CCS(Pension) Rules, 1972. Hence, any change in the Scheme will require the approval of the Cabinet. Hence, the proposal of CWC for counting of 50% of the period of service rendered as Seasonal Khalasis (without temporary status) and 100% of the service rendered as Seasonal Khalasis with temporary status for pension benefits is **not found a fit case case to be agreed to".**
- 3. Hence, all the field offices of this Commission are hereby requested to dispose of these sort of cases on their own in view of the observations made by DoWR, RD&GR as mentioned in para-2 above.
