- G.S.R...(E).... In exercise of the powers conferred by the proviso to article 309 of the Constitution and in supersession of the Ministry of Water Resources, Central Water Commission (Group 'A' Wireless/Telemetry Posts) Rules, 2001 and Central Water Commission (Non-Ministerial Group 'C' posts (Wireless services) Recruitment Rules, 2002, except as respects things done or omitted to be done before such supersession, the President hereby makes the following rules regulating the method of recruitment to the posts of Assistant Director (Communication), Assistant Engineer (Communication) and Junior Engineer (Communication) in the Central Water Commission under the Department of Water Resources, River Development and Rejuvenation, Ministry of Jal Shakti, namely:-Ganga
- 1. Short title and commencement.- (1) These rules may be called the Ministry of Jal Shakti, Department of Water Resources, River Development and Ganga Rejuvenation, Central Water Commission (Group 'A' and Group 'B') Communication Posts Recruitment Rules, 2021.
- (2) They shall come into force on the date of their publication in the Official Gazette.
- 2. Application.- These rules shall apply to the posts specified in column (1) of the Schedule annexed to these rules.
- 3. Number of posts, classification and Level in the Pay Matrix.- The number of the said posts, their classification and the Pay Level in the Pay Matrix attached thereto shall be as specified in columns (2) to (4) of the said Schedule.
- 4. Method of recruitment, age limit and other qualifications, etc.- The method of recruitment to the said posts, age limit, qualifications and other matters relating to the said posts shall be as specified in columns (5) to (13) of the said Schedule.
- 5. Disqualification No person,-
  - (a) who has entered into or contracted a marriage with a person having a spouse living, or

(b) who having a spouse living, has entered into or contracted a marriage with any person,

shall be eligible for appointment to the said posts:

Provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

- 6. Power to relax.- Where the Central Government is of the opinion that it is necessary or expedient so to do, it may, by order for reasons to be recorded in writing and in consultation with the Union Public Service Commission, relax any of the provisions of these rules with respect to any class or category of persons.
- 7. Saving. Nothing in these rules shall affect reservations, relaxation of the age-limit and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes, the Other Backward Classes, Ex-servicemen and other special categories of persons, in accordance with the orders issued by the Central Government from time to time in this regard.
