#### OFFICE MEMORANDUM

Grant of 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> financial upgradation to AD-II/SDE, CWC for cases maturing upto **September 2021**-reg.

The undersigned is directed to refer to DOPT's OM No. 35034/3-Estt.D, dated 19.5.2009 vide which financial upgradation under MACP was introduced and further consolidated guidelines were introduced vide DOPT's OM No. 35034/3/2015-Estt(D) dated 22.10.2019 according to which:

There shall be three financial upgradations under the MACPs, counted from the direct entry grade on completion of 10, 20 and 30 years services, respectively, or 10 years of continuous service in the same Level in Pay Matrix, whichever is earlier.

- Accordingly, a Meeting of the Department Screening Committee (DSC) for grant of 2. 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> financial up-gradation under MACPS, 2009 to all the remaining eligible AD-II/ SDE who have completed their regular services of 10, 20 and 30 years is likely to be convened shortly. All up-gradation cases maturing up-to 30<sup>th</sup> September, 2021 are proposed to be placed before the DSC for consideration.
- It is, therefore, requested that the information as asked in the enclosed check list in 3. respect of all the eligible AD-II/SDE may be submitted to Estt.V Section, CWC latest by 24<sup>th</sup> May, 2021. It is also requested that certified photocopies of relevant entries from service book like date of grant of 1<sup>st</sup> /2<sup>nd</sup> financial upgradation, Major/minor penalty if any, extra ordinary leaves, Suspension period, dies non period etc. should also be sent alongwith checklist. Vigilance Clearance from field should also be sent alongwith these documents. Checklists without such enclosures would not be considered. It may please be noted that in case the Check List is not received by the above date, the DSC Meeting shall be convened without considering the name of concerned candidate and recording the above fact, for which Estt. V Section shall not bear any responsibility.
- All Chief Engineers/Superintending Engineers are requested to send the compiled Check List only in the enclosed prescribed proforma pertaining to the field units under their control. Check list received from Chief Engineers/Superintending Engineers will only be entertained.
- 5. Further, in case the name of any eligible candidate has been left, the same may be brought to the notice of the undersigned.
