I Details of proposed/under construction dams in the Sagar District of Madhya Pradesh.

II Details of proposed/under construction dams under Bina Complex Irrigation and Multipurpose Project(or by whatsoever name it may be called), proposed/under construction dams on Bina, Dhasan, and Dehra rivers in Sagar(more particularly)/Vidisha/Raisen districts of Madhya Pradesh.

III Details of proposed/under construction dam known as Hanota Dam in Pathari and Tyonda tehsil of Vidisha District.

Wherein in above I and II points, Details must be construed as:-

1. Numbers and Names of affected villages due to the construction of proposed/under construction dams.
2. Names(with Panchayat and Tehsil name) of villages in which canals for irrigation of the proposed/under construction dams will be provided.
3. Total area and names(with Panchayat and Tehsil name) of villages which will be benefitted by the availability of water for irrigation due to the construction of proposed/under construction dams.
4. Proposed plans for the inhabitants of the people of affected villages due to the construction of proposed/under construction dams including compensation(its rate) for land, and other payments.
5. Proposed plans for the divergence/reconstruction of roads if any road gets submerged due to the construction of proposed/under construction dams.
6. Other relevant details affecting the lives of people living in the area of proposed/under construction dams due to the construction of proposed/under construction dams.

7. The total cost of proposed/under construction dams and share of Union and State Government in that.
