**APPLICATION UNDER RIGHT TO INFORMATION ACT, 2005****REFERENCES:****KALESWARAM LIFT IRRIGATION PROJECT IN TELANGANA STATE  
MY VARIOUS APPLICATIONS AND CORRESPONDENCE UNDER RIGHT TO

With reference to the above, please furnish the following documents/information to me under the above RTI Act. .

1. Who are the members of the Advisory Committee of your organisation their names and addresses and other details at the time of comprehensive final approval. When was such meeting held and the certified copy of the minutes of the original proceedings be furnished.
2. Without the comprehensive approval, how can the state government proceed with the works. Have you segregated your assessment for the works already done and the redesigned works have been assessed by you. It is totally absurd that you have considered the project as ONGOING project illegally. Do you have the enough authority to do so.
3. Grossly you have not followed your own guidelines in approaching this most corrupt ridden and meaningless project. Do you endorse this statement or not.
4. Please advise whether the then central minister was circulated with this file, if so his remarks may be communicated to me along with the records thereof.
5. It is highly illegal for your chairman and other members to visit the works in tasteful manner and enjoy the state government hospitality time and again having not given the comprehensive sanction. Please give the reasons thereof.
6. The projection cost of the agriculture produce as a result of this project, the power costs, the inputs and outputs for the purpose of B.C. ratio have been criminally and grossly manipulated by you in collusion with the state government which clearly suggest large scale corruption at all levels.
7. You have endangered the lives of millions of people of the State more particularly Hyderabad (just 70 kms away) by approving the parallel barrage at Mallannasagar of a reservoir of 50 TMC which can induce a koyna type seismic effect when completed and breach of the reservoir.
8. It is a gross misconduct and dereliction of duty on the part of CWC that you are reporting NIL about the interstate agreement having raised the question yourself to the state government.

9. It is enough proof that you commission has not considered the risks and maintenance burdens in your assessment to show that you have indulged in large scale corruption in this project including your minister. The project is a colossal failure in the history of irrigation of this country. You are now answerable to the people of the state who have been pushed into a permanent debt trap. The state government is saying that they have changed the project at your instant.
10. A skeleton NOTE to the advisory committee is not the final sanction, please note.
11. Kindly issue immediately orders to the state government to stop all the further works and recommend for CBI enquiry in the matter.
12. Please inform as to whether your organization Central Water Commission is a statutory body empowered with granting mandatory TECHNO ECONOMIC FEASIBLE REPORT FOR THE IRRIGATION PROJECTS IN THE COUNTRY.
13. Please forward a certified copies of the DPRs of Dr. B.R. Ambedkar Pranahita-Chevella Sujala Sravanti project (2010) and Kaleshwaram and Dr. B.R. Ambedkar Pranahita projects submitted the State Government of combined A.P. and Telangana and your comprehensive final approvals.
14. Who are all the states/stakeholders involved in this project. please furnish the copy of the inter-state agreement/agreements reached between/amongst these states as submitted to you.
15. Please forward the assessment report of the contractors who are awarded with the execution of this project before and after changing the design.
16. Several of the phases have been left/relinquished after such works were deleted after spending hundreds and thousands of crores in the name of redesigning. Please furnish the details thereof as notified to you by the state government and as noticed by you in your various inspections/visits.
17. On several occasions you have asked the Government of Telangana to conduct SIMULATION TESTS in the project and submit to you the reports of the same which you have approved. Within a week the Government has submitted to you the manipulated reports to you. It is not possible to conduct the said tests within 5 or 6 days. You are hand in glove with the government. However, please send all the copies of the Simulation Test Results as submitted to you by the government with your office file/records of approval. Also inform me the time required time for such tests to be conducted.
18. So many packages, so many reservoirs, so many canals, millions of units of power and so many phases. No scientific approach. The redesigned project is politically motivated for corrupt personal benefits. You have not even evinced to test the success of the project with at the starting phase. This evidently shows your utter carelessness. Please furnish the copy of the letter you have addressed to the State Government in this regard.
19. Please furnish the copies of the agreement reached by the contractors with the government and among themselves which is mandatory for the state government to submit to you.
20. The B.C. ratio 1.51 has been manipulated/fudged/adjusted with lower figures at the cost of production and with higher figures at benefit level. The cost of power is shown as Rs. 3/- per unit for irrigation purposes. Please furnish the particulars of average cost of power at national level. The agricultural produced has been unduly increased manifold. You have just approved the B.C. ratio 1.51 with closed eyes for reasons best known to you. Please narrate the reasons thereof.
