#### Background:

- 1. This is with reference to the on-line First Appeal No. CWCND/A/E/21/00014 dated 16/06/2021 of Shri Sai Venkat Madamanchi, A M Grand Apartment Plot No.402, JKC Nagar 2 line, Guntur, Andhra Pradesh -522006 received on 18/06/2021 in the office of the First Appellant Authority, WP&P Wing, CWC, New Delhi, from Under Secretary & Nodal Officer, RTI, CWC, New Delhi on ground that "Provided Incomplete, Misleading of False Information".
- 2. The RTI application having No CWCND/R/E/21/00076 dated 07/05/2021 was

received in office of the Dir & CPIO, WP&P Coordination Directorate on transfer from Under Secretary and Nodal Officer, Right to Information, Central Water Commission, New Delhi, vide his letter No A-49012/8/2021/RTI/145 dt 10/05/2021. Under Secretary and Nodal Officer, Right to Information also transferred this RTI application to Director(RMCD) & COPIO RM Wing and SE Cooord & CPIO,KGBO, Hydrabad under RTI Act 2005 of Central Water Commission. The Dir & CPIO, WP&P Coordination Directorate, CWC further transferred this RTI application to Dir D&R Coordination & CPIO, D&R Wing vide No I-12011/58/2021-WPP Coordination/ I/57168/2021 dt 12/05/2021

The First Appeal no.- CWCND/A/E/21/00014 dated 16/06/2021 of Shri Sai Venkat Madamanchi, has also been transferred to First Appellate Authority, i.e CE, (FMO), CE(HSO) New Delhi & CE, KGBO, Hydrabad.

- 3. While scrutinizing the correspondence made, it is found that the above RTI application was received in WP&P Coordination Dte. on 11/05/2021, was further forwarded to provide material for reply to Dir, NP, PA south, Directorate vide CPIO letter No I-12011/52/2021-WPP Coordination/ I/57169/2021 dt 12/05/2021 The reply to the above said application was to be given by 05<sup>th</sup> June 2021 i.e. within 30 days from the date of receipt of the application. The same was also transferred to CPIO D&R Wing CWC vide CPIO letter No I-12011/52/2021-WPP Coordination/ I/57168/2021 dt 12/05/2021
- 4. "As per RTI Act, 2005, a citizen has a right to seek such information from a public authority which is held by the public authority or which is held under its control. It is important to note that only such information can be supplied under the Act which already exists and is held by the public authority or held under the control of the public authority. The Public Information Officer is not supposed to create information; or to interpret information; or to solve the problems raised by the applicants;"
- 5. CPIO of WP&P Wing of CWC vide this office letter No.I-12011/52/2021/WPP Coord/I/59394/2021 dated 04/06/2021 has sent available information to the applicant with remarks for information which were not available, in reply letter that water is the subject of the state government and the state has the right to take decisions or make plans regarding it. Therefore, the applicant is requested to apply / contact the concerned State Government Ministry / Water Resources Department/Local Authorities. Further it is also noted that no DPR of the lift irrigation scheme from dead storage of Polavaram project has been submitted in CWC for appraisal. Hence the reply sent is neither Incomplete, Misleading nor False Information".

6. In light of above, the RTI Application CWCND/R/E/21./00076 dated 07/05/2021 under RTI Act 2005 of Shri Sai Venkat Madamanchi, A M Grand Apartment Plot No.402, JKC Nagar 2 line, Guntur, Andhra Pradesh -522006 which was received in WP&P Coordination Dte on 11/05/2021 shall be considered as settled under the provisions of Right to Information Act, 2005 No further action on the part of CPIO, WP&P Wing of CWC is required.

## 5. **Decision**

In view of the above, CPIO, WP&P Wing of CWC has acted in accordance to the provisions of RTI Act, 2005 and sent the reply at the earliest to the applicant.

In the light of the above, the First Appeal No. CWCND/A/E/21/00014 dated 16/06/2021 of Shri Sai Venkat Madamanchi is hereby disposed
