(a) the details of the cases relating to caste based discrimination and harassment of people being to scheduled Tribes registered against Head of Departments of various Institutions during the last five years and the current year and the status of the investigation;

(b) steps taken by the Government to provide relief to the victims along with the action taken by the Government against the Heads of the Departments found guilty in the investigation of the cases by the National commission of scheduled Tribes;

(c) whether the Government has taken any action against the Institutions and departments which do not comply with the orders given by the National Commission of Scheduled Tribes and Ministry;

(d) if so, the details thereof;

(e) steps taken by the Government to check Government orders, neglect of rules and other irregularities by various Institutions including Delhi university and School of open Learning (SOL); and

(f) the Policy of Government for the institutions challenging the Government's policy and guidelines related to the Scheduled Castes and Scheduled Tribes employees?
