CIRCULAR

Subject: Central Civil Services(Implementation of National Pension Scheme) Rules, 2021-seeking options in the prescribed Form-I &II under the Rule 10 of CCS(Implementation of NPS) Rules, 2021-reg.

The undersigned is to refer to subject cited above and to say that DoP&PW has framed Central Civil Services(Implementation of National Pension Scheme) Rules, 2021, regulating service matters of Central Government employees covered under NPS.

2. As per Rule 10 of CCS(Implementation of NPS) Rules, 2021(copy enclosed), Govt. Servant covered under NPS, at the time of joining service, exercise an option in Form-I for availing benefits under NPS or under CCS(Rules, 1972) or CCS(Extraordinary Pension), Rules, 1939 in case of death or discharge on invalidation or disability of Govt. Servant/Subscriber during service. It is also stated therein that who are already in Govt. Service and are covered by NPS, shall also exercise such option as soon as possible after notification of these rules. They also need to furnish the details of family in Form-II to H/o Office along with Form-I for record and onward transmission to Central Record Keeping Agency.

3. In view of the above, all officers/officials, dealt in Estt-IX section and covered under NPS are requested to furnish their options in the prescribed format in Form- I &II (enclosed) latest by 6.8.2021.
