Terms & Conditions:

- 1. As prescribed vide Ministry of Finance order No. F. No. 24(3)/E.Coord/2018, dtd 26.03.2018 the rate of reimbursement in respect of the officers / officials mentioned above is limited to Rs 1200/- per month (excluding taxes). Any revisions in the ceiling of Rs.1200/- by MoF shall be automatically applicable.
- 2. This revised list of eligible officers shall be made effective from the date of issue of this order.
- 3. Facility of reimbursement of telephone call charges of the residential telephone / mobile phone / broadband / mobile data / data card for vacant posts of DD / EE of field units of CWC may be kept on hold till regular incumbent gets posted / joined.
- 4. The para 4.1 of the DoE OM No. 24(3)/E.Coord/2018 dated 26.03.2018 stipulates that the reimbursement of telephone call charges to the officers of the level of Director / Deputy Secretary to the Govt of India and equivalent level for the residential telephone / mobile phone / broadband / mobile data / data card shall be made with the limit of Rs. 2250/- per month plus taxes as applicable. Therefore, all the STS level officers who have been granted NFSG and drawing pay in the Level-12 of 7th CPC Pay Matrix will be considered equivalent to the Deputy Secretary level officers and will be provided with reimbursement facility accordingly.
