- 1. This Invitation for Bid follows the General Procurement Notice for this Project that appeared in Development Business on 21 Sep 2016.
- 2. The Government of India has received financing from the World Bank towards the cost of National Hydrology Project and it is intended that part of the proceeds will be applied to eligible payments under the contract for which this invitation for Bid is issued.
- 3. The "Financial Part" shall remain unopened in the e-procurement system until the second public Bid opening for the financial part. Any bid or modifications to bid (including discount) received

outside e-procurement system will not be considered. If the office happens to be closed on the date of opening of the bids as specified, the bids will be opened on the next working day at the same time. The electronic bidding system would not allow any late submission of bids.
