## Deal Sir/ Hadak,

The Central Civil Services (Pension) Rules, 1972 were notified around 50 years ago. During the last around 50 years, a number of amendments to these rules were notified and several Office Memorandums, instructions, etc. were issued from time to time, interpreting and clarifying different provisions of these Rules. Since such instructions and clarifications did not form part of the statutory rules, there was a lack of uniformity in their implementation by the various implementing authorities.

- 2. The Government, therefore, decided to rationalize these rules and to bring out a revised version of the pension rules. The task of review and rationalization of the Central Civil Services (Pension) Rules was also included in the strategic initiatives undertaken on the recommendations of the Sectoral Group of Secretaries (SGoS), being monitored by the Cabinet Secretariat/PMO.
- 3. The notification of the new Central Civil Services (Pension) Rules, 2021 has been issued in the Gazette of India vide GSR 868(E) dated 20.12.2021. These new rules have become operational on the date of publication in the Gazette of India i.e 20.12.2021. With the commencement of these Rules, the Central Civil Services (Pension) Rules, 1972 stand repealed.
- 4. In this connection, please refer to this Department's OM of even number dated 21.12.2021 (sent through email dated 21.12.2021) forwarding therewith a soft copy of the new Central Civil Services (Pension) Rules, 2021 notified in the Gazette of India vide GSR 868(E) dated 20.12.2021 for bringing to the notice of all concerned for implementation.
- 5. The soft copies of the above notification GSR 868(E) dated 20.12.2021 (in Hindi and English) and soft copies in booklet formats (in Hindi and English) have been uploaded in this Department's website (https://pensionersportal.gov.in/PensionRules3.aspx) for reference by all concerned.
