Subject: Monitoring of the implementation of reservation policy of ESM in Central Government Ministries/Departments, Banks, CPSEs and CAPFs, - Half Yearly Report.

The undersigned is directed to refer to Department of Ex-Servicemen Welfare Letter dated 10.12.2019 and 03.06.2022 on the subject mentioned above and to state that in order to provide for resettlement of Ex-Servicemen (ESM), the Central Government has stipulated statutory provisions titled Ex-servicemen (Re-employment in Central Civil Services and Posts) Rules, 1979 meant for reservations in jobs for Ex-Servicemen in Central Government Ministries/Departments, Banks, CPSEs and CAPFs. The Directorate General of Re-settlement (DGR) has been designated as the Nodal Agency to assist the Department of Ex-Servicemen welfare, to collect and compile the required data and publish a Half Yearly Report for facilitating monitoring of implementation of Reservation Policy for Ex-Servicemen (ESM).

- 2. In this regard, a meeting was held between Secretary (WR, RD&GR) and DG (Resettlement, Ministry of Defence on 03.06.2022 and later on 15.07.2022 under the chairmanship of Secretary (WR, RD and GR) in hybrid mode while reviewing the pendency issues. All the stakeholders were sensitized to ensure compliance of reservation policy meant for ESM. Secretary desired to ensure that no vacancy reserved for ex-servicemen in a post to be filled otherwise than on the results of an open competitive examination shall be filled by the appointing authority by any general candidate, until or unless the said authority:
 - i. Has obtained a "Non-availability Certificate" from the employment exchange (where a requisition is placed on an employment exchange);
 - ii. Has verified the Non-availability of a suitable candidate by reference to the Director General Resettlement and recorded a certificate to that effect; and
 - iii. Has obtained approval of the Central Government.
- 3. Therefore, all the SMDs (E-I, E-II, E-III, E-IV, Admn, BM, PSU & GWE) are requested to make sure that all the organizations under them are complying with the ESM guidelines, even if it requires amendment in RRs and timely furnish data on ESM Reservation. Further, all the SMDs are requested to furnish the following information/comments (compiled and dully vetted) on all organizations under them:
- Half yearly report for the period ending on 31st December, 2021 & 30th June, 2022.
- Recruitment Plan for 2022-23 with vacancies reserved for ESM.
- Suggestions on how their organization can associate Ex-Servicemen in their activities.

Dear Parkaj,

As you are aware, in order to provide for resettlement of Ex-Servicemen (ESM) in civil life, the Central Government has stipulated for reservations in jobs for Ex-Servicemen in Central Government Ministries/Departments, Banks, CPSEs and CAPFs. The Department of Ex-Servicemen Welfare, Ministry of Defence has been mandated by the Cabinet Secretariat to collect & compile the data/information in respect of Implementation of reservation policy for Ex-Servicemen. The Directorate General of Re-settlement (DGR), has been designated as the Nodal Agency (to assist the Department of Ex-Servicemen Welfare/ Ministry of Defence), to collect and compile the required data and publish a Half Yearly Report for facilitating monitoring of implementation of Reservation Policy for ESM. All these years in the past, the DGR has been regularly requesting all Central Govt. Ministries/Departments to share data on implementation of Reservation Policy for ESM, with limited results.

- Your Ministry/Department has designated Shri AC Mallick, Deputy Secretary (Coord) as 2. the Liaison Officer for collection and monitoring of data (in the attached format) pertaining to ESM reservation as stipulated in DoP&T OM No. 36034/2/2017-Estt.(Res.) dated 31st December, 2021. I have chaired a Liaison Officers' Meeting on 02nd February, 2022 and my Joint Secretary along with DGR have held Liaison Officers' Meeting on 02nd March, 16th March and 04th April, 2022. Despite holding 4 meetings so far, a general lackadaisical approach has been observed in submission of data pertaining to ESM reservation.
- I would request you to instruct your subordinates to furnish timely submission of data for 3. ESM reservation from your Ministry/Department in addition to the Autonomous Institutions,/. Public Sector Banks (PSBs), Public Sector Undertakings (PSUs) and Central Armed Police Force (CAPFs) etc. (if any) functioning under your jurisdiction. I am sure, your kind cooperation shall enable this Ministry to ensure proper utilization of statutory reservation for ESM in full and set them on a second career.

- 1. As per DOP&T Notification No. 36034/1/2006-Estt.(Res) dated 04.10.2012, 10% of the vacancies in the posts upto the level of the Assistant Commandant in all para-military forces, 10% of the vacancies in Group 'C' posts; and 20 % of the vacancies in Group 'D' posts are reserved for Ex-Servicemen (ESM) in Central Govt jobs including permanent vacancies filled initially on a temporary basis and temporary vacancies which are likely to be made permanent or are likely to continue for three months and more, to be filled by direct recruitment in any year shall be reserved for -being filled by ex- servicemen
- 2. Cabinet Secretariat has mandated Deptt of Ex-Servicemen Welfare to collect and compile the data/information in respect of implementation of reservation policy for ESM in Central Govt Ministries/Departments, PSU banks Public Sector Undertakings, Central Para Military Forces etc and other implementing agencies vide their OM 1/21/5/2011Cab dated 16 Dec 2013.
- 3. With the approval of the Competent Authority, Directorate General of Re-settlement (DGR) has been designated as the Nodal Agency on behalf of Deptt of Ex-servicemen Welfare/Min of Defence to collect and compile the required data for facilitating monitoring of implementation of reservation policy for ESM.
- 4. All Central Government Ministries/Depttt., PSU Banks, Public Sector Undertakings, Central Para Military Forces etc. and other implementing agencies were requested to furnish data as per the enclosed proforma half yearly w.e.f. 01/01/2014 directly to the Nodal agency i.e. DGR vide MoD letter No 25(1)/2010/D(Res-1) dated 04 Jun 2014 and 13 Aug 2014 respectively.
- 5. The requisite data pertaining to your Department/Attached /Subordinate Offices for the half year ending 31 Dec 2019 may be forwarded in the enclosed prescribed revised format latest by 31 Jan 2020 positively.

Reservation in Govt jobs has been provided by the Govt for the Ex-Servicemen for their resettlement in civil life due to their early retirement from the armed forces to maintain a youthful profile. It would not be out of place to mention that Resettlement of Ex-servicemen and their employment in nation building is a focus area of the Hon'ble Prime Minister.
