

Chairman, OWC has decided that the following officers of the Central Training Unit of the Commission established recently at Pune, can also exercise all such powers i.e. Works, Financial, Administrative etc., as have been delegated by him formally to their counterparts working in the subordinate offices of the Commission, is indicated below :-

	<u>Designation of the CTU Officer</u>	<u>Extent of powers delegated</u>
i)	Chief Engineer, Central Training Unit	Full powers as delegated to the Chief Engineers, incharge of field formations of the Commission.
ii)	Director, Environmental Science Agriculture and Irrigation Engineering (Director ESAIE) CTU	Full powers delegated to Superintending Engineers incharge of Circles of OWC.
iii)	Dy. Director (Admn. & Coord.)CTU	Full powers delegated to Executive Engineers incharge of Divisional offices.

2. Exercise of these powers is subject to the limitations, restrictions scales and observance of procedures and checks mentioned in the relevant substantive rules, government orders as also subject to general and special orders & instructions issued by the government and OWC from time to time.
