The above officers will continue to carry out the assigned job pertaining to Rapid Risk Assessment of dams, irrespective of their place of posting.

The Core group eventually shall consist of about 50-60 officers viz CWC (11 No.'s), NDSA (12 No.'s), State Govt/PSU dam owning agencies (25-35 No.'s) and DRIP Consultants (2 No.'s).

The officers of the Core Group shall undergo two weeks of training on the use and application of the Rapid Risk Assessment Tool by the experts from World Bank. The training shall be held during 22<sup>nd</sup> April 2024 to 3<sup>rd</sup> May 2024 at CWC, New Delhi in physical mode. On successful completion of the training, the officers of the Core Group will carry out initially the risk assessment of about 100 dams included in DRIP. Subsequently, they shall impart the training on the use and application of the Rapid Risk Assessment Tool to the dam owing agencies; and review the risk assessment carried out by the dam owning agencies. The whole exercise of Rapid Risk Assessment is targeted to be completed by June 2025 (14 months' period).
