As you are aware, Government of India is organizing Special Campaign 5.0 from October 2nd - October 31st, 2025.

2. In a follow up to the Cabinet Secretary's DO letter No.502/2/2/2024-CA. V/CA.III dated 30th July, 2025, DARPG has issued detailed guidelines for implementation of Special Campaign 5.0 vide OM No. Q-11011/01/2025-O&M-DARPG (e-9571) dated 01st August, 2025 (Copies enclosed). The focus of the campaign shall be on filed/outstation offices responsible for service delivery or having public interface in addition to the Ministries/Departments and their attached/subordinate offices. Under waste management, the focus will be on disposal/management of e-waste generated in Government offices, as per rules (copy enclosed). The Campaign is expected to cover outstation Post Offices, Railway Stations and other public offices in mission mode during the month-long campaign.

It gives me great pleasure to inform you that Department of Administrative Reforms and Public Grievances (DARPG) is organizing a 'Workshop on Cyber Swacchhata' with an objective to create awareness about the need of Cyber Security in collaboration with CERT-In as part of Cyber Swachhata initiatives on 08th October, 2025 (Wednesday) at the Auditorium, Civil Services Officers Institute (CSOI), Vinay Marg, New Delhi from 03.00 PM to 05:00 PM. The schedule of the Workshop is enclosed. The focus is on strengthening cybersecurity measures of e-Office, Bhavishya and CPGRAMS platforms which are administered by DARPG and DPPW.
