OFFICE ORDER

In pursuance of C.C.S.(Revised) Pay Rules, 2016 notified vide Ministry of Finance, Dept. of Expenditure's, G.S.R.No 721(E) dated 25.07.2016 (F.No 1-2/2016-IC) and their O.M. No 1-5/2016-IC dated 29.07.2016, on implementation of recommendations of 7th Central Pay Commission, the pay of Smt. T.P. Kerketta, Deputy Secretary, CWC (HQ) is hereby revised w.e.f. 1.1.2016, as per option exercised by her as under:

- (I) Pre-revised pay structure: PB-3 Rs. 15600-39100+7600 (Grade Pay)
(II) Revised pay structure: **Level 12** of Pay Matrix (*Minimum Basic Pay Rs. 78800/-*)

2. The above officer will be entitled for the payment of allowances as per instructions contained in O.M. No 1-5/2016-IC dated 29.07.2016 issued by Ministry of Finance, Dept. of Expenditure in this regard.



3 In terms of Para-7 of the Ministry of Finance, Dept. of Expenditure O.M. No 1-5/2016-IC dated 29.07.2016, the arrears as accruing on account of revised pay consequent upon fixation of pay under CCS(RP) Rules, 2016 w.e.f. 1.1.2016 shall be paid in cash in one installment along with the payment of salary for the month of August, 2016, after making necessary adjustment on account of GPF and NPS, as applicable, in view of the revised pay. DDOs/PAOs shall ensure that action is taken simultaneously in regard to Government's contribution towards enhanced subscription.

4. The above fixation of pay and payments of arrears arising thereof, if any, is subject to audit observations.
